8. <u>Regular Agenda</u>

8.1. Executive director report: 2023 Year in Review

- Nelson presented the attached PowerPoint, noting that it is a focus on our program areas not our strategic plan and it does not address work completed in administrative or policy realms, and that because we provide comprehensive, integrated, holistic natural resource management, many of our projects and programs really touch on more than one focal area.
- Stielstra said that it is amazing to try and visualize an aerial map of all the projects.
- Etherton said it inspired her to see it all and asked if it will appear in the website or in an email.
- Nelson said that the power presentation will be in the minutes.
- Nelson said that we should be looking for groups who we can present this to.
- Kossy asks if there are any questions and thanks everyone for what they do.
- Nelson and Kipreos are almost finished with the JEDI plan and it is really coming together. She is excited to bring that graph to the board and staff.
- Nelson discussed JEDI related topics about women in the workplace like construction sites. She has had conversations with staff who are women. We are not a traditional workplace where we have control over all the experiences they might have. Others might say or do things to women on staff that they would be accountable for if they were on staff, but they are not on staff. Discussion with staff has included how men on staff can be allies. There is no current crisis or big problem but Nelson wants everyone on staff to feel safe.
- Nelson said another interesting JEDI topic is conversations we are having regarding tribal politics. She discussed the complexities of different claims

regarding territories, how staff is navigating this, and being very clear that our role is to help people help the land and not be arbiters of legitimacy. It is very complex.

- Nelson reported that we did sponsor the farmworker conference at Puente. We had 2 staff tabling the event who are Spanish speakers. The individual sessions were not open to people who were not farm workers, so that they had a safe space to talk about their needs.
- Nelson said we are developing a work plan for the many administrative projects we need. Getting them all done will take some time.
- Nelson may not backfill Adria's position due to the contraction in the economy and State budget deficit.
- She asked for grace and empathy because her current workload is astonishingly high. There is so much we want to do and improve administratively but it is hard to get staff capacity when we don't have the operating base.
- Kossy thanks Nelson for letting the board know about her workload since it is always a good reminder for them.

8.2. USDA NRCS (Natural Resources Conservation Service) report, Jim Howard

- ∉ NRCS is all about Farm Bill program workload these days.
- ∉ Tremendous amount of funding coming from the Inflation Reduction Act is going to carbon sequestration and reduction in greenhouse gasses.
- ∉ NRCS is all in on getting 2024 Farm Bill conservation program contracts. They are doing really well.
- ∉ In SMC, there are 7 customers funded on various contracts this year across different programs like grazing, conservation, soil health work, and energy conservation.
- ∉ He is wrapping up his workload and going to help other counties who are behind.
- ∉ He is trying to hire a soil conservationist for the Half Moon Bay local partnership office.
- ∉ He explained how they took a 30% cut in their conservation technical assistance funds which can include things like salary agreements. Fortunately Carlos Suarez, State Conservationist, had planned the budget for that type of cut.
- ∉ He will have another forestry intern this summer in our office.
- ∉ RCD staff helped out a lot last year and gave the intern a lot of valuable experience. He is looking forward to it happening again.
- ∉ He discussed the value of regional meetings in connecting with colleagues and achieving the NRCS mission. He wishes the regional RCD meetings were taken a bit more seriously.
- ∉ Stielstra agreed. Especially with how short the meetings are and how far some people travel to them, they could be much more.
- ✓ Nelson said she believes it goes back to how the regional meetings are created in the bylaws and that she is on a CARCD committee looking at that and is looking to improve the meetings. Many RCDs don't have the knowledge or resources to host the meetings and need support.
- ∉ Howard said some of the RCD's feel isolated and don't feel the support or network. It would be nice if there was a way to support each other.
- ∉ Nelson reminded the board that Howard is only being here for one year after being here for 20 years.

Re: Notice of contract amendment with L.D. Giacomini Enterprises Inc. for the Butano Creek Backfield Floodplain and Streamflow Enhancement Project

The RCD is amending its contract with L.D. Giacomini Enterprises Inc. (Giacomini) to complete implementation of the Butano Creek Backfield Floodplain and Streamflow Enhancement Project.

Giacomini completed the floodplain enhancement components of the project in summer 2023 and will be completing the streamflow enhancement components in summer 2024. Both components were funded and permitted as a single project and the RCD board of directors approved contracting with Giacomini for both components of the work in June 2023 (Appendix A). The original contract with Giacomini did not include all anticipated work because the streamflow enhancement designs and associated cost estimates were not yet completed. The contract amendment enables completion of the remaining work.

The amendment increases the contract amount by \$1,946,260 based on the completed designs and estimates developed by the project engineer, Storesund Consulting, as well as bid documents submitted by Giacomini on March 8, 2024.

Giacomini was originally selected through a competitive bid process in spring 2023, although a competitive bid is not required for private property per section 4.3.1 of the RCD's Procurement Policy, "Projects on Private Land." Additionally, per section 5.2.2 of the procurement policy, competitive procurement is not required when services are from a contractor who previously satisfactorily performed/provided the work for that project. Giacomini meets these criteria.

RCD staff recommends the board of directors approve contracting with L.D. Giacomini Enterprises Inc. to implement the Butano Creek Backfield Floodplain and Streamflow Enhancement Project. This project will benefit threatened and endangered species and other wildlife, enhance agricultural viability on the land, improve streamflow, and store sediment in support of downstream flood mitigation, implementing the Pescadero-Butano Sediment TMDL, and protecting the dredge project.

Work will include floodplain reconnection, improved channel complexity, and instream low enhancement components, all of which will have direct and indirect benefits to instream and adjacent floodplain and terrestrial habitats. It will create 4.2 acres of stage zero floodplain by lowering the current floodplain surface by as much as several feet, allowing the stream to access the lowered floodplain during winter baseflow conditions. It will place 15 to 20 habitat structures (roughness elements) within the newly created floodplain surface and adds inchannel habitat features, including one engineered logjam and several post-assisted log structures/living riffles to improve complexity and arrest incision.

A Request for Bids was distributed to approximately nine construction contractors and shared publicly via the RCD's website, Half Moon Bay Review, and four trade journals. Six firms attended a mandatory pre-bid site tour. Two of the six firms submitted bids, both by the deadline of May 16, 2023. Bids were opened during a public bid opening held on May 16, 2023 with the following results:

- L.D. Giacomini Enterprises Inc. (\$1,453,279.00)
- Hanford Applied Restoration & Conservation (\$1,978,355.00)

RCD and the consulting engineer for the project reviewed the bid documents and determined that L.D. Giacomini Enterprises Inc. is the lowest cost responsible bidder for the project. L.D. Giacomini Enterprises Inc. has experience working on projects involving creeks, large wood, and restoration. Additionally, the RCD worked with the firm to successfully complete the Dark Gulch Crossing Stabilization Project.





Exhibit B Project Site-Scale Map
